Associate Princess

Hello all my quarantine buddies! I hope everyone is healthy at home and have everything they need to keep safe. Please reach out to me if you have need. I will do everything I can to assist you.

I want to thank the court for electing me to Associate Princess. I enjoyed my time as

your 1st Ceremonial Lady; getting to talk to many potential and new members.

I have chosen our court project for the year 2020-2021 from the Spokane Hospital. It is their motion analysis program. This is a 2-3 hours movement study that uses advanced computer technology and therapy. This study provides helpful information to guide the course of treatment for appx 200 children every year. The cost of this study is \$1,550.00 per study. I would love to be able to provide for at least 3 children this year.

There is a YouTube video you can watch that shows what each child goes through and learn more about it. On your phone, tablet or computer; open YouTube and enter "Spokane Shriner's Hospital Movement Analysis Lab", then you can watch the video. This program helps recognize orthopedic and

other issues. Part of this study includes 3-D motion capture, oxygen use, and foot pressure.

During this unique time of our lives, the hospitals are restricting donated items, the current list from Salt Lake is: gift cards; dolls/super hero figures; toy cars and trucks; play-doh sets; coloring books, colored pencils, markers, and crayons; toys for infants and toddlers; video games for X-box or Wii; new release DVDs; Legos; and blue-tooth speakers and headphones. You may have noticed that blankets and other soft goods are missing from this list. At this time, they are not accepting these, so we are not collecting these for the hospitals until they inform me differently.

The Spokane hospital is also in need of face masks. They have sent me patterns and instructions for making face masks. Please contact me if you would like to make some and I will send you the

details.

Sorry for the length of this article, but, I wanted everyone to know what we are collecting for this year even though we don't know when we will be able to meet in person. Take care and sending you all a 'virtual' hug. You are all in my thoughts.


